This Procurement Notice is issued by the Government of Bermuda (the "Government") to provide summary information in relation to a specific procurement, as detailed below.

1. Subject Matter of Procurement

RFX Title: Floating Docks Surveying and Replacement Design

RFX Number: 61-01-150-01

Purchase Type: Service

The Government seeks to engage a suitably qualified engineering firm to design the replacement for the floating ferry docks at Hamilton Ferry Terminal, Dockyard Ferry Terminal and Hamilton Marine and Ports Depot using existing mooring piles. The existing floating barges are heavily corroded and beyond repair. Reuse of existing gangways, platforms and ramps if possible is preferred.

The scope of the project includes surveying of the as-built terminals and condition assessment of elements that may be reused; preparing a replacement design proposal; and producing construction drawings, specifications and cost estimates.
