Name of Public Authority: Department of Statistics

Introduction

The Public Access to Information Act 2010 aims to give the public the right to obtain access to information held by public authorities to the greatest extent possible, subject to exceptions that are in the public interest or for the protection of the rights of others. Additionally, the aim is to increase the transparency of public authorities' information and how their business is conducted.

PART 2, Section 5 (1) of the Act, sets out the legal duty of the Department of Statistics to produce an Information Statement detailing specific information about its role, functions, services provided, and other information as listed in Clauses (a) to (i) of Section 5 (1) of the Act.

This Information Statement will inform the public of readily available information and data accessible in the Department in which written requests are not required to obtain the data. The Information Statement will also serve as a public awareness tool about the Department's role, function, services and outputs produced.

Section A: Structure, Organization and Legislation [s5(1)a]


Structure

The organisational structure of the Department comprises four (4) broad divisions, which include the operational function of the Department and the subject matter statistical activities, namely:

- Administration Division – Responsible for managing departmental operations, personnel, and administrative support functions.
- Business Statistics Division – Responsible for producing and analysing the consumer price index, unemployment and employment statistics.
- Economic Statistics Division – Responsible for producing and analysing gross domestic product, the information and communication technology profile, balance of payments and international investment position statistics, the retail sales index, and the tourism satellite account report.
- Social and Research Statistics Division – Responsible for producing and analysing demographic, vital, census, environmental, trade, and household income and expenditure statistics.

The Department falls under the Ministry of Economy & Labour. The Permanent Secretary has the umbrella of authority over the Department providing strategic leadership to the Director of Statistics, who is responsible for leading and managing the Department's operations and statistical work programme. Within the Department, three subject-matter Statisticians report to the Senior Statistician who in turn reports to the Director to deliver the core statistical outputs under each respective work Division.

Legislation

The Department is the Government's official statistical agency. The legislative framework governing the work of the Department is embodied in the *Statistics Act 2002*, Section 4, Clauses (a) to (e) under the sub-title: Duties of Director.

These include to:

- Collect, compile, collate, analyse, abstract and publish statistical information relating to the commercial, industrial, social, financial, economic, and general activities and conditions of the people of Bermuda;
- Take any census of population and housing in Bermuda;
- Collaborate with Ministries, other Government Departments and public authorities in the collection, compilation, collation and publication of statistical information, including statistics derived from the activities of those Ministries, departments or public authorities;
- Promote the avoidance of duplication in the information collected by Ministries, other Government Departments and public authorities; and,
- Promote, organise and develop an integrated scheme of economic and social statistics relating to Bermuda.

The Department's production of statistics is guided by international statistical standards and best practices that enable comparisons of statistical data with those of other countries worldwide.

A broad range of statistical data is collected subject to the provisions of the First Schedule in the *Statistics Act, 2002*, which lists the types of data collected. Data is collected through administrative records and by conducting business or household censuses and surveys on a monthly, quarterly, semi-annual, annual or ad hoc basis.

Per Section 7 of the *Statistics Act, 2002*, relating to disclosing the information collected by the Department, any data or information obtained under the *Statistics Act 2002* shall not be disclosed or cause to be disclosed in such a manner that it is possible from the disclosure to relate the particulars obtained from any individual return to any identifiable individual person, business or organisation. As such, the data accessible to the public is always produced in aggregate form.

Hence, any requests for data and information at a level that will disclose the individual information of a person, organisation or business are deemed exempt under Part 4, Section 23 (1) of the *Public Access to Information Act, 2010* unless the Director has received written consent from the person, business or organisation.

Section B: I) Functions, powers, duties of the Authority [s5(1)b]

The mission of the Department is to produce and provide statistical information for data-driven decision-making for Bermuda.

The Department functions and delivers against its four (4) departmental objectives:

- Raise the Department of Statistics profile through improved accessibility to statistical data and information utilising innovative digital tools by March 2027.
- Ensure the collection, compilation and production of statistical outputs are based on the most current international statistical methodologies, standards and best practices by using data quality frameworks by March 2027.
- Operate a transparent and citizen-centric department by improving the understanding and use of statistical data and information by March 2027.

- Engage in targeted external and internal training and development to build the statistical capacity required to sustain a high-performing department by March 2027.

Within the functioning of these departmental objectives, the Department delivers official statistics and information to all key stakeholders.

The Government relies on timely, accurate and reliable statistical data and information for evidence-based macro-economic management, social reformation, and policy making to fulfil its commitment to the people of Bermuda. Other key stakeholders in the business community use statistical data to inform decisions on the strategic direction of their entities. International organisations such as the United Nations, the World Bank and the International Monetary Fund use the statistics for international comparisons with other countries.

The Department is one of many national statistical offices that make up the global network of statistical agencies, along with international and regional organisations such as the United Nations Statistical Division, the Caribbean Community Secretariat Statistics Division and the Caribbean Regional Technical Assistance Centre. The collaborative partnerships formed because of international networking has elevated the knowledge, skills and technical expertise of officers, thereby strengthening the intellectual statistical capacity within Government. Consequently, the Department has been positioned to make great strides in expanding its work programme to produce statistics in alignment with the needs of the Government and other stakeholders.

Section B: 2) Obligations under PATI Act [s5(1)b]

The Department comprises twenty-one (21) permanently funded positions as outlined in the organisational chart above. The Director of Statistics is the Accounting Officer, reporting directly to the Permanent Secretary. The Minister responsible is the Honourable Minister of Economy and Labour.

Financial Performance

Fiscal year current and capital account estimates for the Department (Head 14) are detailed in the Government's Annual Report of Revenue and Expenditure, outlining actual, revised, and original budget estimates. The budgeted monies are expended as required in alignment with Financial Instructions; and policies, code of practices and procedures stipulated by the Budget Office, Ministry of Finance, and the Office of Project Management and Procurement. Financial and compliance audits of the Department's operational activities are carried out by the Department of Internal Audit on an ad hoc basis.

The Department's Comptroller conducts monthly reviews of the Department's expenditures and produces current account performance reports for budget monitoring.

Section C: Services and Programmes [s5(1)c]

Services

The Department provides official socio-economic and environmental statistics about Bermuda via publications, social media and customer requests.

Additionally, the Department has the responsibility to provide statistical consultancy and technical advice to other Government Departments.

Programmes

The Department's core function is to collect, compile, collate, analyse, and publish statistical information relating to the general activities and social, financial, economic, and environmental conditions of the people of Bermuda.

The Department's statistical work is conducted under the authority of the *Statistics Act, 2002*, and the *Statistics (Disclosure of Information) Regulations, 2002*. All business and household surveys and censuses are mandatory, and by law. Respondents must provide the Department with the requested information. The Department conducts surveys and censuses using multi-modal data collection methods that include:

1. Online completion of questionnaires – Questionnaires are completed online by the respondent.
2. Computer-Assisted Telephone Interviews – Interviews are conducted over the telephone while the interviewer is prompted by an electronic questionnaire and keys responses directly into a computer data file.
3. Computer-Assisted Personal Interviews – Questions are uploaded onto devices which are then used as the data collection instrument to conduct face-to-face interviews.
4. Telephone Assisted Paper Interviews – Interviews are conducted over the telephone using a pencil and printed questionnaire.
5. Pencil and Paper Interviews – Interviews are conducted face-to-face using a pencil and printed questionnaire.

Section D: Records and documents held [s5(1)d]

Classes of Records

The broad classes of statistical information provided to the public are grouped accordingly:

- Economic Statistics – via the conduct of economic surveys and administrative data
- Business Statistics – via the conduct of business censuses, surveys and administrative data
- Social and Research Statistics – via the conduct of household censuses and surveys and administrative data

Section E: Administration (all public access) manuals [s5(1)e]**Policies and Procedures**

It is the vision of the Department to attract, develop and retain human capital that will meet the current and future demands of the statistical work programme. The recruitment process within the Government of Bermuda is centralised. The Department of Employee and Organizational Development has established a standard recruitment procedure for the hiring of officers to ensure the process is carried out fairly and consistently.

The Government of Bermuda is committed to achieving and maintaining the highest standards of safety in compliance with the revised *Health and Safety Work Act 1988*. The Department has a Safety and Health Committee which meets monthly.

The Department's standards for the delivery of statistical outputs and services are steered by four (4) broad principles, namely: Timeliness, Quality, Professionalism and Confidentiality. In this regard, each Statistics Division has developed Metadata documents outlining specific methodologies used for the production and delivery of the Department's core statistical outputs.

Section F: Decision-making documents [s5(1)f]

The Department stays abreast of current international best practices and standards of delivery for statistical data and information. The standards used for statistical methodologies, concepts, definitions and classification systems align with principles and guidelines stipulated by international agencies such as the United Nations, the International Labour Organization, the World Bank, the International Monetary Fund and the Caribbean Regional Technical Assistance Centre. In making decisions about statistical methodologies used for data collection, compilation and processing, the Department is mindful of customising such methodologies to ensure relevancy for the Bermuda social, economic, business and environmental context.

As it relates to officers' work conduct and disciplinary procedures, decisions are made in alignment with the *Conditions of Employment and Code of Conduct*, the *Bermuda Public Service Union Collective Agreement*, the *Employment Act 2000* and the *Public Service Commission Regulations, 2001*.

To affect its overall operational activities, the Department works primarily in partnership with the Department of Employee and Organizational Development; the Accountant General's Department; the Ministry of Finance; the Department of Communications; and the Department of Information and Digital Technologies.
