### **A. THE DELIVERABLES**

#### **Dumping**

1. All vegetation to be dumped at Marsh Folly must be no longer than six feet (6) in length.
2. All material to be dumped must be separated by type (sand and soil, vegetation) before being taken to be dumped at the relevant facility the Airport Dump (sand and soil) or Marsh Folly (vegetation).
