3.1. *Secure perimeter wall from inmates.*

## **4. Project Scope and Objectives**

- 4.1. *Install a 10' high Chain-link Fence on playing field, ten (10) feet inside the existing perimeter wall. The Specifications for the fence is as follows:*
- 4.2. *All vertical poles to be schedule 40 x 3" galvanized and installed in the earth with 3000 psi concrete a minimum of 36". Poles to be 8' c/c*
- 4.3. *Security Fence to be 10' high x 6 gauge galvanized with openings of 2½" x 2½".*
- 4.4. *Structure to be reinforced with 1 5/8" galvanized rails at top, center and bottom*
- 4.5. *Chain-link to be attached to structure with aluminum ties*
- 4.6. *Galvanized Ys' to be installed at top of poles to take Razor wire*
- 4.7. *Razor wire to be 30" Maze Reinforced Concertina and attached to Ys' with stainless steel wire*
- 4.8. *Four (4) gates with galvanized hinges to be installed in fence*
- 4.9. *Gates to be 2'-8" x 6'-8" and made of schedule 40 x 2" galvanized material*
- 4.10. *All other accessories used to be galvanized steel..*



## **5. Terms and Conditions**

- 5.1. *Payment terms – 50% at start of contract and remainder on completion*
- 5.2. *Warranty – 12 months material and labour.*

## **6. Change of scope**

- 6.1. *N/A*
