



## PROCUREMENT NOTICE

This Procurement Notice is issued by the Government of Bermuda (the “Government”) to provide summary information in relation to a specific procurement, as detailed below.

### 1. Subject Matter of Procurement

RFX Title: **Purchase of Tub Grinder**

RFX Number: **2021-003Q-MPW**

Purchase Type: **Goods**

The Department of Works and Engineering, Waste Management Section under the Ministry of Public Works operations the Marsh Folly Composting Facility which is located in Pembroke, Bermuda. The Marsh Folly Composting Facility accepts leaves and wood waste and produces compost. It operations from Monday to Saturday on pre-determined hours.

The Department is seeking bids for one (1) mobile wood and green waste processing machine - an industrial tub grinder for the Marsh Folly site. The industrial tub grinder will be used to recycle wood and green waste.

Respondents must also provide information on the following:

Warranties, guarantees: bids must be submit with full disclosure of any and all warranty rems, conditions and tenures, including optional extended warranties or guarantees, accompanied by their respective costs when and if applicable.

Shop manuals, parts list: available shop manuals, owner's manuals and parts lists for the Tub Grinder to be tendered to the Government of Bermuda at time of delivery.

Delivery: Bid price must be delivered to an US port with shipping lines to Hamilton, Bermuda. Cost of Sea Freight, Customs Clearance and inland transportation from the Port of Hamilton will remain the responsibility of the Government of Bermuda.

Parts, Service, Warranty: all parts, service, and warranty work must be guaranteed by successful bidder, with all work being done at the location.
