Clarification needed on specification was wondering if there is a typing error. As Published:

4000 MT #7 Asphalt Rock; ASTM D448-12

4500 MT Sand (Dirty); ASTM 1073-6 Grade 1

6000 MT Sand (Washed); ASTM 1076-6 Grade 1 (modified)

R1

The specification for 4500 MT Sand (Dirty) is ASTM 1073-16 Grade 1

The specification for 6000 MT Sand (Washed) is ASTM 1073-16 Grade 1 (modified)

Q2

The total volumes requested will be difficult to place on a single vessel shipment. Can a proposal be submitted for the requested quantities and an alternate proposal submitted for with reduced quantities be acceptable?

R2

Proposals submitted with the requested quantities and smaller quantities are acceptable. The reduced proposal should be submitted as an alternate proposal.

Q3 Is this duty exempt?

R3

Pricing must be provided in Bermuda funds, exclusive of all applicable duties and taxes. Bermuda government will pay the duty.

Q4

Page 23 of the RFP main doc Lab Certification – which are you referring, the lab on island we have our aggregates tested or overseas (from our suppliers)? What is the certification to include?

R4

Proponents must provide testing from their overseas facility. Government will validate the testing overseas with a private lab and do the testing in Bermuda.

Q5

Scale Certification – overseas (suppliers) or on island scale? If on island, is each truck load to be weighed before delivered to the quarry? What is the certification to include?

R5

The Scale Certification overseas must be certified by local authorities. On island weighting will not be needed.
